Dear Artist,

By reviewing this document, both parties agree to all stipulations below for the Art Exhibit and Sale organized by Stars In The Arts.

All artwork needs to be ready to hang - wired or framed. After the show, all artworks must be picked up at the stipulated time/day unless arranged with curators otherwise. SITA and Gallery are not responsible for the artworks left behind.

Artwork Sales:

•Salespeople will be assigned to the sales transactions. ALL artists agree that 10% of the total sale price will go to a charity and 20% is considered a commission for Stars In The Arts.

Remember to include your tax sale within your price.

Please consider your calculation as follows in this example:

The price of your piece should already include the 30% for commission/donation, and include a tax of 8.875% within this price. *Stars in the Arts will be collecting the sales payments and disbursing them, usually within a week or two after the show. We will pay the taxes, deduct the 30%, and disburse the remainder. Example: you want \$100 for your piece, so you will write down \$141.53.

Every artist accepted will have a Google profile sheet with contact and art information available to buyers. See email for deadline.

A non-refundable fee of \$100 will be collected from all participating artists with hanging art, payable via **Zelle** only, to starsinthearts18@gmail.com. This fee will be used to cover show expenses. See email for deadline.

We encourage artists to hand over their sold artwork to the collector at the time of the show. You can also arrange to deliver your art to the buyer, no later than 5 days after the show. We recommend that artists include a certificate of authenticity with sold pieces. SITA will not hold your artwork for later delivery.

Liability: Please note that we are not an insured entity. While we will be most careful and respectful with your pieces, we will not be responsible for any damages or theft from the gallery. If this is a concern for you, please insure your work privately.

You, the artist, hereby grant Stars in the Arts the right to use your photograph and/or your artwork's image and image of live event on our social media platforms, including, but not limited to, Instagram, Facebook, and website.

WAIVER, RELEASE, AND INDEMNITY

I, the undersigned, on behalf of myself and any representatives, assigns, and third party acting on my behalf, in consideration of being permitted to participate in "77 Exhibit (collectively, the "Exhibit") by *Stars In The Arts* and their organizers Lilian Kebudi and Annette Back (collectively, the "Organizers"), represent and agree as follows:

1. I acknowledge that participating in the Exhibit may involve certain risks, some of which I may not fully appreciate, and that injury, death, property damage, or other harm could occur to me or others. I assume and voluntarily accept all risks of any injury, damage, or harm that may arise during or as a result of participating in the Exhibit. I know of no reason, medical or otherwise, that would prevent me from performing tasks required to participate in the Activity.
2. I waive all claims against the Organizers and the owner of the property where or upon which the Exhibit occurs (that owner, the "Organizers" and that property, the "Premises") for any injuries, damages, losses, or claims, whether known and unknown, which arise during or from the Exhibit. I understand that the Organizers and the Premises (collectively, the "Releasee") are not responsible for conditions that I create or that are created by others. I hereby release and forever discharge the Releasee from all such claims.
3. I, binding my heirs, executors, administrators and assigns, hereby agree to release, hold harmless, and indemnify the Releasee and their officers, trustees, employees, agents, and volunteers from and against any and all losses, liabilities, damages, costs, or expenses, including, without limitation, for bodily injury, death, personal injury, property damage, claims, demands, costs, judgments, intellectual property infringement, fees, and/or attorney's fees that arise directly or indirectly during or from my participation or the participation of third parties under my direction or control in the Activity.
4. I agree to provide defense for and defend, at my sole expense, any and all claims, demands, or causes of action against Releasee directly or indirectly arising out of my participation or the participation of any third parties under my direction or control in the Activity, and to bear all other costs and expenses related thereto.
5. I agree to remove all my artwork or other materials brought into or onto the Premises by me and to restore the Premises to a clean space. SITA is not responsible for any artwork left on premises after the conclusion of the art exhibit.
6. I understand and agree that at no time shall I be considered an employee of the Releasee. I further understand and acknowledge that the Releasee will not provide insurance coverage for me.
7. I will provide immediate written notice to the Releasee if I learn that any cause of action or claim relating to the Activity has been or may be initiated against Releasee.
8. I authorize, consent, and agree to permit the Organizers to publish my image and images of my artwork, if any, including any photographs or videos thereof, for the limited, non-commercial use of promoting the Exhibit on the Organizers website and social media outlets or in print or television media. Notwithstanding, the Organizers acknowledges that no transfer of copyright is intended hereby.
9. The provisions of this Waiver, Release, and Indemnity (the "Agreement") shall survive the expiration, termination, or other cancellation of any agreement between the participating artist and the Organizers.

I have carefully read and reviewed this Agreement, understand it fully, and execute it voluntarily.

If the participant in the Activity is under the age of 18, then this Agreement must be signed by the participant's parent or legal guardian.
